The Registered Office of the Trust shall be at 1-15-22 M1, Shanmuga Complex, New Edappadi Road, Sankari or at such other place or places as the Trustees may decide upon from time to time.

This Trust shall be an IRREVOCABLE PUBLIC CHARITABLE TRUST for the benefit of general public without any discrimination as to caste, creed community or religion.

The sum of Rs. 1,001/= (Rupees one thousand and one only) endowed by the Author of the Trust and mentioned above together with further accretions thereof and other funds or properties which may be endowed to the trust shall be held in trust only for the objects set out hereunder. The objects of the Trust shall be:

- i. To support the cause of and spread education and to establish, take over and admisnister schools, colleges, technical institutions, hostels and other educational institutions.
- ii. To establish and administer hospitals and dispensaries for the welfare of the public and to afford medical releif to the sick and suffering irrespective of casts, community or creek
- iii. To establish and administer orphanages, home for aged and the destitute, and houses for the blind and mentally retarded without any distinction as to race, relegion or creed.

The trust shall be managed and run by a committee of trustees consisting of the following persons at present:

All the trustees will hold their office till their lifetime or they voluntarily resign from the said post whichever is earlier.

Any vacancy that may arise in the Board shall be filled by co-option by the Trustees. Unless otherwise determined by the Board of Trustees, the number of Trustees shall not exceed Six. Till the co-option is made, the affairs of the Trust shall be conducted by the continuing Trustees and all acts done by them shall be binding on the Trust.

The Trustees shall have and may exercise all or any of the following powers as they may consider necessary desirable for and in/or connection with Trust purposes.

a) To purchase, hire, take on lease, lands and movable or immovable properties, accept loans on such terms and conditions and (where applicable) subject to payment of interest or otherwise as the board of Trustees may consider necessary or desirable.

- b) To receive donations and endowments from any person including firms, campanies, charities or other trusts or funds, for the object of the Trust on such terms and conditions as may be accepted by the Trustees.
- c) To invest the donations received in any property whether movable or immovable or by way of advance or loan and shall also be entitled to deposit the amount at a fixed rate of interest with any bank, company, firm or other institutions.
 - d) To change one form of investment into another as they deem fit and proper.
- e). To deal with sell, mortgage, charge, lease, hire, invest, transferinvestments open bank accounts and generally deal with Trust Fund or any part thereof as the board of Trustees may consider necessary or desirable.
- f) To borrow any monies from Government or Local Authority or Company or any person with or without security for the purpose of carrying out the objects of the Trust.
- g). To institute and conduct or defend any legal or other proceedings in the name of Trust of against the Trust as the case may be to engage counsel or attorneys and to give them such vakalats or Power of Attorney as may be necessary from time to time.
 - h). To frame rules and bye-laws for the conduct of the business of the Trust and of its transactions.
- i). The Trust account shall be opened with a Nationalized or Scheduled Bank and shall be operated jointly or severally by the Trustees P.Shanmugam and P.Mani.

The funds of the trust shall be invested only in accordance with the provisions of Section 13(1)(d) read with Section 11(5) of the Income - Tax Act.

All moneys including the main corpus of the trust and of accumulations and receipts of this trust shall be held only in the name of this Trust and not in any individual name or names of Trustees.

The accounts of the Trust shall be maintained properly and shall be closed on the 31st, March every year.

The accounts of the Trust shall be audited every year by a Chartered Accountant.

The net income arising out of the Trust properties whether movable or immovable, after meeting the necessary expenses shall be utilized only for all or any of the aforesaid objects, in India alone.

The Trust shall not carry on any activity outside India.

The Trustees shall utilize the funds of the Trust and the income derived therefrom only towards the objects of the trust and no portion of these monies shall be utilized for payment to the Trustees by way of profit, interest, dividents or on any other head.

The trust shall not carry on any activity with an intention to make a profit.

The Trustees shall be entitled to appoint such staff for administering the trust property on such terms as they may decide and shall have the power to dismiss the persons so appointed.

In the event of the Trust being dissolved or wound up, the assets of the Trust shall be transferred to Trusts or charitable Institutions having object as the Trust.

Any amendment to the deed of trust shall be carried out only with the approval of the commissioner of Incom -tax.

No immovable property is involved by this Trust Deed at present.
